Sequential Brands Group, Inc. Annual Meeting of Stockholders will be held on June 8, 2018 at 601 West 26<sup>th</sup> Street, 9<sup>th</sup> Floor, New York, NY 10001, at 10:00 a.m. Eastern Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** each nominee listed in Proposal 1, **FOR** Proposals 2 and 3, and **AGAINST** Proposal 4:

1. Election of Class I Directors.
2. To ratify the selection of CohnReznick LLP as our independent registered public accounting firm for the fiscal year ending December 31, 2018.
3. To approve, on an advisory basis, the compensation of our named executive officers.
4. Stockholder proposal to implement a majority voting standard in our governance documents if properly presented at the meeting.
